7. Reports from Borough & County Councillors

Councillor Blackburn reported that there had been an article in the Yorkshire Post from Barratts saying that £160,000 had been spent locally in Cayton. He said it was very misleading as it really referred to the \$106 money. He said at the moment County had not indicated when the \$106 money is going to be spent. The members agreed a letter could be sent to North Yorkshire County Council asking when the monies are to be spent as the article is miss leading. County had made a suggestion that maybe the bus stop could go outside Jubilee Hall, all councillors were completely against that idea. The 2 matrix signs will be temporary for 18 weeks during the year at a cost of £6,000 for 4 years - no cost to the parish, as it will come out of the \$106 money. Roads to the south of Main Street are to be surface dressed. Councillor Mrs Swiers & Councillor Green reported that there had been some complaints re flooding on the new estate- wasn't too serious. Barratts have advised rubbish bins are in hand. They have only 12 houses to sell, & they should be completed end of May beginning of June. Play equipment still to be provided. It was RESOLVED that the councillors be thanked for their reports.
